- A section on the estimate of relevance of the project to our primary aim, which is replacing the use of animals in biomedical research. This should include referenced details of the animal experiments that the project is designed to replace, and estimated numbers and species of animals involved. In summary, this section should include an estimate of how your research will help towards reducing the use of animals in your own and other laboratories.
- A full CV for each applicant and any person for whom a salary is requested.
- Names of appropriate scientific/medical referees.
